- Original passport of the applicant (no photocopy)
- A copy of the round trip ticket or itinerary confirmation bearing the name of the applicant
- Payment of the visa fee (Cash, Bank Transfer)*
- A yellow fever vaccination certificate is required if the traveller stayed in an affected area six (06) days prior to the trip

IMPORTANT: APPLICANTS MUST NOT PROCEED TO PAYMENT UNTIL PROMPTED TO DO SO
